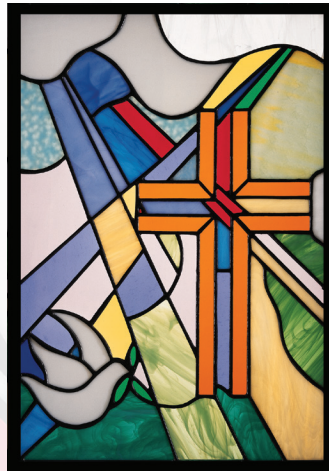

Investing in Our People

The most sophisticated medical equipment cannot function without trained, competent people. The most potent medications cannot cure without skilled caregivers to administer them. And the health care ministry of Baptist Health System cannot provide the highest standards of quality patient care without investment in its people.

Your contributions make possible that investment in our physicians, nurses, allied health professionals and all those who support the health care team.

In 2013, your gifts provided tuition for parish nurse training. As a result, a WMU parish nurse is now able help to members of church congregations manage symptoms of chronic illness, offer screenings and other activities to improve health at the congregational level.

Awards such as the Ida V. Moffett Memorial Scholarship Award, Ida V. Moffett Caring Award, Marion A. Marx Nursing Scholarship and Hugh Linder Award totaled more than \$17,000 to recognize performance excellence by employees across BHS.

Rewarding performance excellence continued with the recipients of the Homer Lloyd award reinvesting in opportunities that reflect BHS Mission values. Bob Phillip's award made it possible for him to attend an Estes Park Institute Conference in San Diego, CA that offered good insight into national healthcare trends.

Safety for patients and employees is always a concern and high on the list. Last year, Foundation funding made \$2,500 available for lead aprons and special protective glasses for staff in Princeton Baptist's cardiac catheterization lab. For the safety of patients and employees, a HoverJack® was provided for the Bariatric Center at Princeton. Its inventive inflatable design helps the staff safely raise obese patients from the floor to a bed or standing position. It's safer for both and more mindful of the patient's dignity.

Continuing education is key to sustaining excellence and exceeding patient expectations. Whether it's a one day seminar, a lengthy fellowship or an indepth certification process, professional development is encouraged. Your gifts provided continuing education for staff in Cardiac Rehab, the Breast Care Center, Cancer Registry and other departments.

Investing in Patient Care

As Baptist Health System's faith-based ministry approaches the 100-year mark, it remains steadfast to its mission: compassionate care to those in need, regardless of their ability to pay. With your help, the four BHS hospitals provided more than \$750,000 in charitable patient care last year.

Through the BHS Employee Benevolent Fund, employees are able to help co-workers in distress – perhaps because of illness, natural disaster or other calamity. But, through EBF, employees also assist patients in difficulty. Last year, the fund provided approximately \$158,000 to lighten burdens, elevate spirits and lengthen lives...thanks to the compassion of BHS employees.

Contributions to enhance cardiology services at the BHS hospitals this past year benefitted patients and strengthened our position as a cardiac specialty leader. Princeton and Shelby were recognized for "Quality in Cardiac Care" by Blue Cross and Blue Shield of Alabama. The Blue Distinction Center designation was awarded to them for delivery of quality and cost-efficient cardiac procedures.

Innovative programs and services are essential to meet evolving community needs. A Foundation grant addressed the need for appliances in the Bariatric Center kitchen, where classes teach obesity patients and families healthful food preparation. The needed equipment was purchased at the hospital Princeton Auxiliary's "Appliance Sale" fundraiser, which resulted in maximum benefits – a "family discount" price for the Bariatric Center and ultimately the amount paid was part of the Auxiliary's contribution to the Foundation.

Care for our smallest patients was addressed with renovation of the Neonatal Intensive Care Unit at Shelby. As the only NICU between downtown Birmingham and Montgomery, investing in a top-notch, well-equipped NICU is critically important.

Proceeds from the Alabama Charity Clays made possible innovative services for breast cancer patients. The Breast Care Navigation program at Princeton offers assistance to patients in maneuvering the challenges of breast cancer during evaluation, treatment and recovery. This new approach provides a navigator to help patients access needed resources.

The Breast Care Fund helped make possible a partnership with St. Vincent's to offer greater patient access to lymphedema rehabilitation.

Investing in quality patient care improves the patient experience and saves lives.

Investing in Technology

Innovative technology is not limited to high tech surgical equipment. It may not be a new type of MRI or CT. Sometimes it can be a teaching tool that allows health care staff to hone their skills in a non-critical environment.

A state-of-the-art simulation program made possible through a \$30,000 Foundation innovation grant was implemented at Princeton Baptist. SimMom™ is the latest innovation in obstetrical simulation, combining computer technology with anatomical accuracy to provide realistic training scenarios. SimMom™ and her obstetrical complications are but the first step in a risk-free training program for simulated experiences with a patient in cardiac, trauma or other crisis situations.

With its newly opened geriatric psychiatric unit, Shelby Baptist incorporated a similar high-tech training approach with the Geri™ Nursing Skills Manikin provided by your donations to the Foundation. The elderly appearing “manikin” has realistic positionable arms to accommodate blood pressure and intravenous practice techniques and has proved ideal for use in multiple areas of training.

Treatment begins with a diagnosis. And Foundation funding for new EKG scanners and an SICU ultrasound Doppler at Shelby provided new advances in diagnostic imaging technology.

A gift from Birmingham Radiology Group’s Dr. Davor Luketic made possible new workstations for radiology departments at Walker and Citizens Baptist Medical Centers.

Radiation therapy for patients at Princeton was improved through a new scanner, which was funded by your donations.

The Breast Care Center at Princeton now boasts advanced, new equipment. In addition to mammography paddles, a top-of-the-line “mammography phantom” provides calibration for optimal image quality and system sensitivity. Both reinforce the Center’s ongoing efforts to offer the most accurate and precise images to help diagnosing breast abnormalities.

Patients of all ages – infants to adults – undergoing aerosol therapy at Princeton can now benefit from an Aeroneb ProX. This sophisticated nebulizer effectively delivers medications to patients either on or off mechanical ventilators.

Remote patient monitoring became even more high tech with new 4-pulse oximeters at Princeton. Worn on the fingertip, the Bluetooth-enabled device measures blood oxygen saturation, pulse rates and perfusion index.

High tech combined with high touch at BHS hospitals results in high satisfaction scores from the patients we serve.

The outreach of those medical ministries missions spanned the globe to touch lives and souls in Haiti, Israel, Honduras, Mexico, Ecuador, Kenya, Dominican Republic, Guatemala, Cambodia and beyond.

Closer to home, our hospitals and employees answered the call to improve community health.

The Faith Clinic, in partnership with the Shelby County Community Health Foundation, provided free medical care in the Shelby County area. Another partnership with Birmingham Baptist Association, Baptist Health Centers and e3 Medical was a pilot for an initiative to offer church-based, free community medical clinics. More than 92 patients were treated in only three days one of these clinics at True Vine Evangelical Church in northeastern Birmingham.

A longstanding success story is the Princeton Achievers, which introduces teens to careers in health care. Your gifts funded 20 Princeton Achiever scholarships, totaling more than \$10,000 to assist graduating seniors with advanced education.

Your generosity made possible a new chapel and a much-needed classroom – part of Princeton’s recent major expansion. The chapel serves as a focal point of the hospital’s new atrium. The quiet space, complete with new Bibles – another gift – offers an ideal space for prayer and meditation for patients, families and staff alike.

At each BHS hospital, volunteer auxiliaries donated their talents, time and resources to enhance the patient experience. An outstanding example was support from the Princeton Auxiliary that continues to bring comfort to grieving families suffering the loss of a newborn.

Thank you for your support, which allows our faith-based values to be demonstrated in our care, our hospitals, our communities and beyond.
